## Responding to Requests for Production or Inspection

The California Code of Civil Procedure now requires “ [a]ny documents or category of documents produced in response to a demand for inspection, copying, testing,

or sampling shall be identified with the specific request number to which the documents respond.” Cal. Civ. Pro. § 2031.280 (a). This is a major departure from the prior rule.

### **Rule 34. Producing Documents, Electronically Stored ...**

(A) Time to Respond. The party to whom the request is directed must respond in writing within 30 days after being served or — if the request was delivered under Rule 26(d)(2) — within 30 days after the parties’ first Rule 26(f) conference. A shorter or longer time may be stipulated to under Rule 29 or be ordered by the court.

In short, there are four basic code-compliant responses one must utilize, in whole or in part, for each particular RPD: (1) There will be no production of any documents whatsoever based solely upon a legal objection(s); (2) There will be a production of all documents without any objection; (3) There will be a production of documents, in part, in that some documents will not be produced based upon a legal objection(s) and/or an inability to comply; and (4) There will be no production of any ...

### **Practice Guidance: Objections to Discovery Requests ...**

Federal Rule of Civil Procedure 34, which governs document request responses, was revised in late 2015 to require that responses now "state with specificity the ground for objecting and state whether any responsive materials are being withheld on the basis of that objection."

### **Response Letter to a Request: Format (with Samples)**

### **Best practices in responding to requests for production ...**

Responses to requests for production are due within thirty (30) days (five (5) days in unlawful detainer actions) if the requests were personally served, thirty-five (35) days if the requests were served by mail, and thirty (30) days plus two (2) court days if the requests were served by express mail or facsimile or electronically.

### **Bing: Responding To Document Requests**

Even if the taxpayer doesn't have the requested documents, or if they are already in the possession of the IRS, such response should be put in writing. To the extent
