Even in Jordan, Indonesia and Malaysia - Muslim countries with progressive images - the relatively secular ruling elite sit atop Muslim masses, 71%, 72% and 86% respectively of whom want their countries to be ruled by Sharia. And in Iraq, where the United States has been propping up democracy since 2003, 91% of its Muslims want to live under the Sharia law.

Finally, it argues that since public international law is not secular in nature, but rather 'neutral' so as to 'accommodate' Muslim states. Siyar only strengthens the obligations of Muslim states and does not impose Islamic law on non-Muslim states.
